Hadley suggested working with the schools as the best way to spread the word about healthy eating. Perhaps hosting parent/child cooking classes. We encourage the new Membership Coordinator to attend Board meeting or at least give a month report of membership and outreach.

Finance committee will work on store and Board budget for the January meeting.

<u>Board Development:</u> Mark will send a membership list so we can review it and find a working member to head the committee. The committee needs to review material and candidates.

<u>Terms/Handbook/Committees:</u> Terms will be discussed in executive session. Mia will send copies of the handbook to the Board for review and it will discussed at January meeting. Committees will be reviewed in January to decide if they are still serving their purpose.

<u>Meetings:</u> In January the Board will decide all the meetings for 2015 after everyone reviews their personal calendars. Bylaws state the Board only needs to meet quarterly and monthly has been hard with such a large Board so we plan to find a balance.

The Board approved sending Congratulations cards with \$50 Co-op gift cards to Aaron & Julia.

Executive Session Decision: The Board approved that Mia has so far served only one full 3 year term and approves her ability to run for a second term; thus fulfilling a 2nd consecutive term.
